

# Advocate Christ Medical Center Center for Prehospital Care EMS Academy EMT Course

The Center for Prehospital Care is pleased to announce the next EMS Academy EMT Course. Sessions will begin January 17 and 18, 2018, with graduation scheduled May 2018. Classes will be held on Monday/Wednesday (10 am-2 pm) or Tuesday/Thursday (6 pm-10 pm) at Advocate Christ Medical Center's EMS Academy Campus, 5220 W. 105th Street, Oak Lawn.



The cost of the course is \$1250, which includes a **\$250.00 non-refundable deposit**. Tuition covers books, lab fees, TB testing, background check, I.D., uniform shirt, and AHA Healthcare Provider CPR course.

Students will be required to purchase a stethoscope and a watch with a second-hand for use in class, clinical, and ambulance experiences. Students will also need to purchase black or blue Docker-style pants and a pair of comfortable black shoes (no gym shoes).

Students will be enrolled as Moraine Valley Community College students and will receive MVCC credits. There is no additional cost to the student for these credits, but you must be a student in good standing with MVCC. This means if you have attended MVCC in the past, you must be free of any financial or academic holds.

**PLEASE BE ADVISED THE REQUIREMENTS LISTED BELOW MUST BE COMPLETED BY FEBRUARY 26/27, 2018:**

- Copy of state issued photo I.D.
- Copy of Birth Certificate for proof of age.
- Copies of GED/high school transcripts; college transcripts are acceptable only if a degree has been obtained.
- Completed Health Assessment from Advocate Christ Medical Center Employee Health (approx. \$56.00 fee required). For appointments call 708.684.5333. Please note that appointments should be scheduled within 30 days of the start of the course, no sooner. **A copy of your immunization record is required at the time of your health assessment.**
- Student will be required to pass a background check (no felony charges). This will be conducted through Advocate Health Care. NO refund is given if student fails any portion of the background check.
